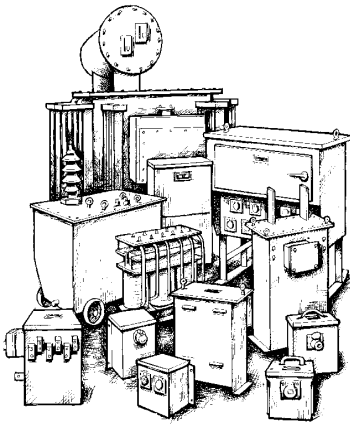

4. Your Rights

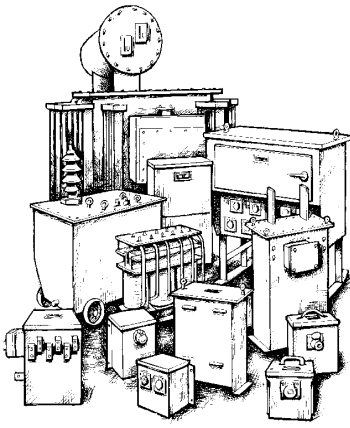
4.1 As a data subject you have the following rights under the GDPR in relation to your Data:

6.4 You have the right to question the use of your personal data at any time (See Section 4)

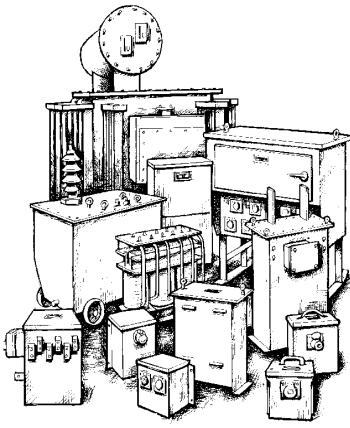
6.5 We will not share any of your data with any third party for any purposes
